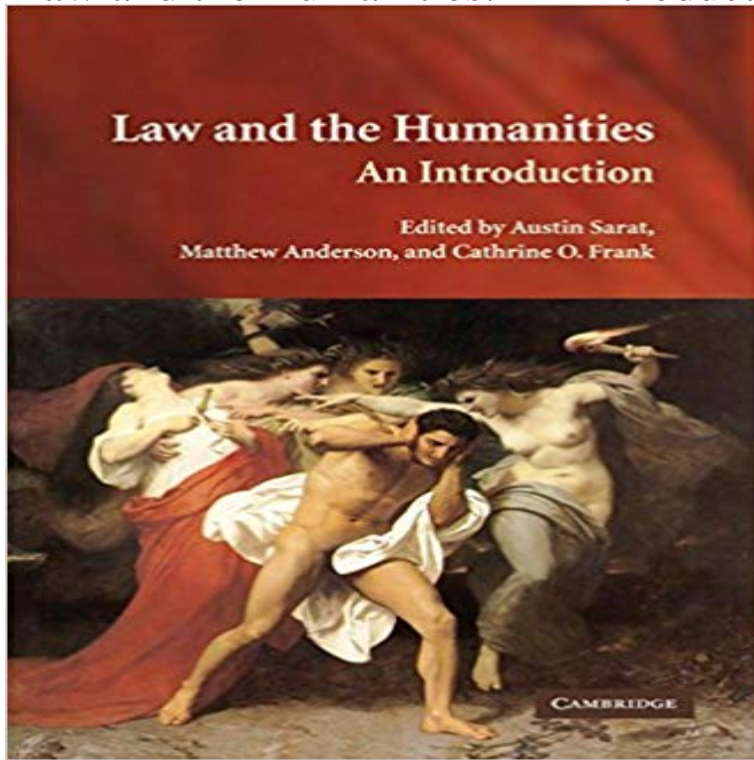


Law and the Humanities: An Introduction
