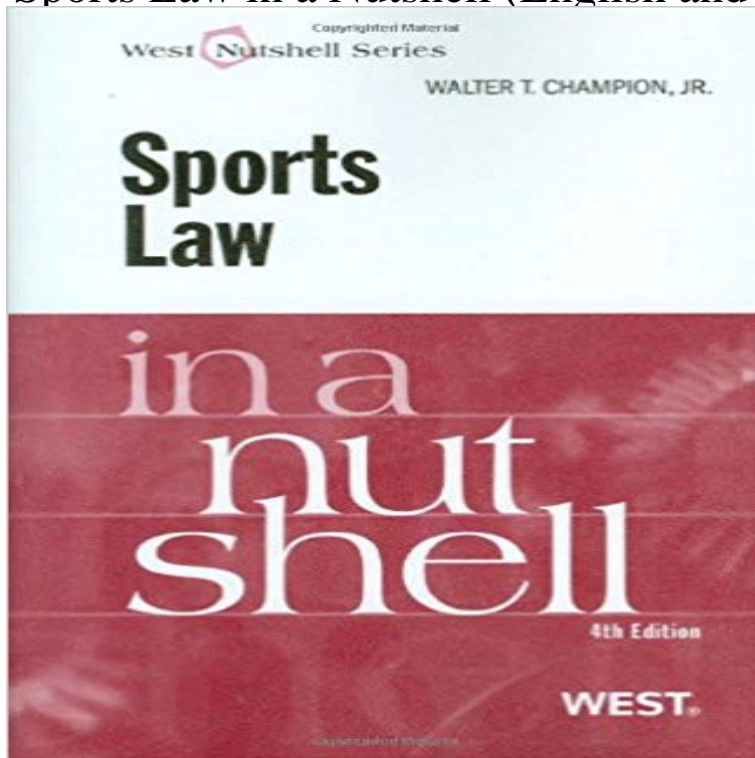


Sports Law in a Nutshell (English and English Edition)
