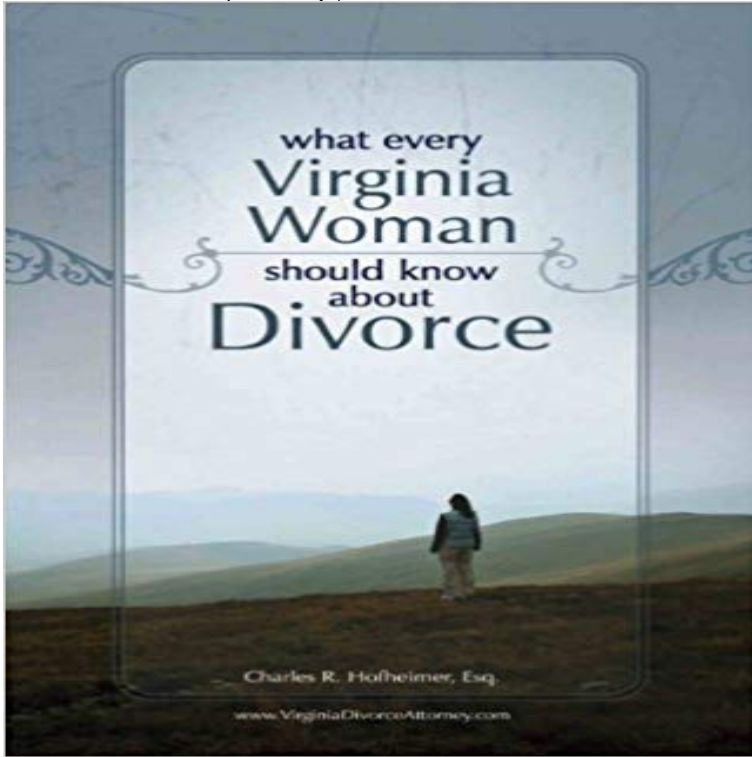


What Every Virginia Woman Should Know About Divorce
